## A SHORT HISTORY OF THE WEST TEXAS ANNUAL CONFERENCE.


The Methodist Episcopal Church was re-organized in Annual Conference relation in Louisiana, December 25, 1865, by Bishop Thompson.

The Conference included the states of Mississippi, Louisiana and Texas. The Conference was known as the Mississippi Mission Conference. Only three sessions were held of this conference, January 1868, the Texas annual Conference was organized and this conference included the whole of Texas. In 1873, the West Texas Conference was organized out of the western division of the Texas Conference. The West Texas Conference when organized, was com-

posed of three districts and a membership of 3000.

It has develope its territory into six districts and a membership of more than 15,000. It has help to build our beloved Samuel Huston College, with Prof. R. S. Lovinggood at its head and a strong faculty to help him, its doing untold good for the race, country and the church.

#### PROCEEDINGS.

#### FIRST DAY-MORNING SESSION.

The West Texas Annual Conference met in its thirtyninth annual session in St. Paul Methodist Episcopal Church, San Antonio, Texas, Thursday, at 8:30 a. m, November 23, 1911.

By appointment of Bishop Thos. B. Neeley, D. D., Rev. J. S. Wyatt, acted president. The devotional exercises were conducted by Rev. Jas. Hutcherson from 8:30 a. m. to 9 a.m.

Rev. J. S. Wyatt the acting president with the assistance of the other District Superintendents of the Conference and Revs. J. M. Johnson, B. M. Taylor, District Superintendents of the Texas Annual Conference of the Methodist Episcopal Church, administered the Lord's Supper to one-hundred and forty-five persons. The fire from above came down and all hearts were warmed by its presence. At the close of this service, the president called upon the Secretary, T. H. Wyatt, of the last Annual Conference to call the roll. All members present answered to their names. Four of number, that had toiled and labored with us, had been called during the year, to their heavenly home, to weep with their Conference berthren no more, but to rejoice with the angels ever more. Viz: Revs. C. P. Westbrooks, A. J. Lynch, J. W. Mitchell and Robert Dukes. After the singing of hymn, "Bless Be The Tie That Binds" the Conference was led in prayer by Rev. Lee Reed, who offered a fervent prayer to the throne of grace in behalf of the love ones of our deceased, brethren, that had crossed the river.

Waters, Dallas District, R. Sodia of the San Antonio District. J. G. Brown of the San Angelo District, J. H. Swann of the Waco District, as assistants.

By a motion of Rev. B. J. Goff, the Rev. Alfred Brown was re-elected Treasurer with Revs. J. C. Eusan, J. W. Wormley, A. L. Carper and P. M. Carmichael as assistants.







Lovinggood, president of Samuel Huston College, who spoke of his work in brief, and the new Industrial Building now completed for the boys, and he further made announcements of the Annual Conference Samuel Huston's Rally on Friday night, and plead with the Conference for \$2000.00 in the above name rally. The Freedmen's Aid Society asked the Conference for \$510.00 another Conference year. By motion of T. H.


#### MEMORIALS.

At the close of the memorial services Rev. A. Brown, sang as a solo, "Fade Fade, Each Earthly Joy, Jusus is Mine," etc. All eyes were wet with tears, and each of the members of the Conference thought of that day when they too, would be called from labor to reward. (See memorials by Rev. A. Brown.)

Rev. Dr. C. P. Westbrooks joined the West Texas Conference in 1885, and died December, 1910 at Milferd, Tex. He came from the state of Mississippi and taught school in Goliad for several years. He was a graduate of Walden University, Nashville, Tenn., and was an able expounder of God's word, he held several leading charges of our conference and was very ambitious and was loved by the brethren of our conference. Dr. Westbrooks was our Statistical Secretary for over twenty years. Let me tell you something touching the long illness of Dr. Westbrooks and finally his death. I remember really the night when Dr. Westbrooks received his death warrant. Let me come up to it through a piece of poetry. Beneath our feet and over our head, Are equeal warnings given, Beneath us lie the countless dead, Above us is the Heaven, Death rides on every stream, And lurks in every flower, Each season has its own own disease, It perils every hour. Rev. Dr. Westbrooks was conducting a camp meeting at Columbus, Texas eight years ago. One night he lost control of himself by preaching to hard hearted sinners. He exhausted himself until he spit blood. I said, Dr. Westbooks, you will never get over it. It followed him. You talk about



the queen of the South rising up in the judgement with this generation, but the king of kings will put many a preacher on the stand in the day of judgement, and make us a swift witness against them for their hard heartedness. God's book tells you so. O! how we are scattered here and there; our families are burried in different graves. The burning message compels us to go. Bishop Coke, even sleeps in the Indian Ocean, Bishop Kingsburry at Beyrut, Fitzgerald in Hongkong, China, Wiley in Foochow, China, and our wives and children are here and there, no family grave yard. But in the getting up morning those graves must give us back our loved ones. Then, Oh! the family reunion in glory. After all this separation those partings, these different burying grounds don't amount to any thing with that glory that shall be given to us after while. Let us count our suffering a duty and not a task.

Rev. J. W. Mitchell was born in Murry County, Tenn. December 30, 1847 and died December 7, 1910 at Bremond, Texas. making him about eixty-one years of age.

He joined the West Texas Conference in 1878, and served till 1897, ninteen years in the ranks after which he took a Superannuated relation and held this relation 6 years and was again made effective and served until 1907 and then again was Superannuated. Rev. Mitchell served also in the United States army and received a pension as he was honorably dis-







#### THE SPIRITUAL CONDITION.


The spiritual conditon on the District is fair, several revivals with good results, several conversion and goodly numbers added to the Church.

#### REPORT OF F. L. Kirkpatrick.


Dear Bishop and Brorhers of the West Texas Conference:

Bishop, we are poor down here, but in a humble way we are trying to do the work of the master.

#### OUR MINISTRY

Our ministers as a whole stuck to their post. Some of them with fair good work and some with very poor work; those in poor charges were forced to do manual labor to help support their families, and after all you can see Bishop a hopeful set of Christain men. Bishop, we are in need of more men, men who are willing to sacrifice, and men who are able intellectually to do the work of the ministry. There are one or two men on the Austin District, who are forced to locate and we are using supplies in few of our charges to carry on the work, but after all there will be an increase on all lines in our church work. I began my work this conference year, with the Georgetown and Hutto Circuit, the Rev. W. B. Lott as Pastor, he knows how to pastor. During the four years he and his people erected a new parsonage, and now he has torn down the old church, and is ready to build a Three Thousand Dollar Church in Georgetown, and his report will show several conversions and accessions to the church, and increase on General Benevolence. His people desires his return.

From Columbus, we went to Alleyton and Eagle Lake, where the Rev. S. W. Harvey is pastor. He has done some very needy repair in Alleyton, and plans to erect our church in Eagle Lake that was wrecked by the storm.

Columbus Circuit, where the Rev. G. E. Tyler was pastor. I must say it was always a pleasure to meet this busy active pastor and good people. Rev. Tyler has worked hard to bring success to his work. The parsonage has been repaired at a cost of \$50. seated his church at a cost of \$30. and built a nice fence around the same.

They asked for his return. Edna and Morales. The Rev. J. H. Napier has wrought well. Repaired church in Edna at a cost of \$75.00, seated his church at Morales at a cost of \$60.00. Built a new church at Lavaca and completed it at a cost of \$1236.00, all paid execpt \$50.00. His work is spiritually alive. He has increased in benevolent collections Wharton and Bay City. Supplied by Rev. M.W. Stevens. This energetic young man has work hard. His report will show for it self, Goliad Charge. Rev. A. J. This organization has puzzled the best brain to successfully operate them, but I am pleased to say that on the Columbus district we have a few chapters that are yet alive and are doing good work.

#### LADIES AID SOCIETY.

This department of our church has marched steadily along this year, several new chapters have been organized,



and wherever they operate do untold good for pastors and churches. The pastor who fails to organize does not enjoy the fullness of the ministry.

## THE WOMAN'S HOME MISSIONARY SOCIETY.

These women have been faithful to every duty and have worked unceasingly for the church and our Eliza Dee Home located at Austin, Texas, and we as pastors are going to stand by these good women and Miss King, our worthy Superintendent. You fail, we fail, you succeed, we succeed.

#### SAMUEL HUSTON COLLEGE.

Our people have not supported our school as they should have. Some of our laymen, sorry to say discourages our young people in attending our church school, therefore many are hindered in securing a christian education which better prepares them for lif's duties. Samuel Huston College stands for all that is necessary in helping a complete life. I urge that we stand by our Prof. R. S. Lovinggood and our Samuel Huston College with our money and our prayers, so that the work that has begun fail not.

#### OUR NEEDS.

We need better Sunday Schools, a wide awake Superintendent in every organized Sunday School who will be truly a missionary, who will love to sacrifice and lift up the people. Our district needs closer organizations so as to bring the best results to our work. We need a better paid ministry and a great awakening in raising our benevolent claims. We need soul stirring revivals that will bring about a great change in the life of the people. We need more money for education so as to push our work on to success. We need to extend our work down to the Gulf, so as to prepare to save the people. The mass of our people live in lower counties: Matagorda, Jackson, etc., therefore it is advisable to follow up the people. An Article appeared in the Bulletin a few days ago relative to lost of membership during the last ten years. I think I can help solve the this problem. For more than ten years the people on the Columbus district have been shifting from one place to another, seeking better fields of labor.



Proof. You take the counties: Colorado, Fayett, Gonzales, Dewitt, Lavaca, have decreased in population, Colorado, 14.9; Lavaca, 6; Dewitt, 10.2; Fayett, 18.5; Gonzales, 2.9; and many of them are Negroes who have gone West and a goodly number have moved into the lower counties where wages are better, and in some cases property is cheaper. These people have gone and the church has failed to follow them. I am sure that if the church will follow up these people and see to it that our folks have the gospel it would indeed increase our work. We need a self sacrificing set of local preachers who are God sent and God called to be pioneers in these new fields.

#### EXTENSION OF WORK.

We have tried to extend our border and take in neglected territory. The places where we have gone, viz: Pin Oak and Garwood, Drybranch, Port Lavaca, Placedo and Markham, Texas are places where some of our people have moved and they are there without a shepherd of our denomination.

I have traveled about 8569 miles in the discharge of my duty, preached and lectured 208 times, I have presented all claims, held or caused to be held 4 quarterly conferences in every pastoral charges save one. I have done every thing in my power to advance the district.





#### DALLAS DISTRICT.

San Antonio, Texas, November 23, 1911. Mr. President and members of the West Texas Conference. It is my pleasure to make my Fourth Annual report to you of my labors, and the general condition of the Dallas District. I have worked this year as I have in the past ones with all the earnestness and power that was possible in that of lecturing, praying, and trying to preach, as best I could to inspire, encourage, build up my people, and the District materially, financially and spiritually. The condititions have not been so favorable in any respect. First, we have had the most severe drouth in that part of the State ever witnessed by the older settlers, which practically ruined the corn, wheat, and oat crops, leaving the people nothing to depend on but cotton. This has affected our people and the whole of this section very materially in a financial way. Under these conditions the people in most places were scattered over the country gathering cotton, leaving some of our Churches with so few, the pastors were hardly able to hold any services at all a part of the time. This had the effect of working great hardships on the Pastors and their families, and too, I am sure it will effect our reports very much, especially those who put off raising their Renevolences until Fall, instead of beginning with the year as I had advised, but we hope to surpass any previous year's report. We noticed a report in ths Bulletin referring to the non-increased memberships of our Church in ours and other parts of the State, but we are glad to say that such has not been the case for the last four years. There have been good revivals in each charge and circuit, which resulted in form one to fifty conversions. We have been able to draw equally on other Denominations, as they have on us.



In nearly all the towns of North Texas in the small or large ones, our people are divided up into five or six different Denominations, leaving in many places just a few for every church, which is not the case in Central Western, nor Southern Texas. However the membership of the Dallas District has almost doubled itself in four years. Our people there are not as they are in Southern and Western Texas owing their forms, saving two settlements, Pelham and Mexia Circuits, which has caused or given us a transient people. This coupled up with mob violence, and white copism has almost deppopulated our people in some of the rural section, and in some of the small towns, because of lawlessness, or no protection by the civil authorities. These conditions have caused many of our members, and converts to leave our bounds and go to Oklahoma, Arkansas, and California had this not been our membership would be near twenty five or thirty hundred.


#### IMPROVEMENTS.

Rev. Dennis, and the people of Pelham have built a new church, on a new site, which is one among the neatest and specious in the Conference, at a cost of nearly two thousand dollars. The greater part of which is paid for. Rev. Duncan and his people at Elm Grove have an improvement to the church there increasing its comfort, and space nearly hundred per cent. Rev. George Waters and his people at Ennis and Ferris have done some improvement in beautifying the churches at each place. Dr. N. J. Johnson and the people of St. Paul, have paid off the Parsonage debt of some long standing, and have torn down the old St. Paul Church, preparatory to build a fine Edifice which will be a credit. At this junction we are forced to pen the sad words that Dr C. P. Westbrook, who started off with us in the new conference year has fallen. On his return from the Annual Conference the following evening, the same being December the 6th. at 10 p.m. God took him. This scholar, teacher and preacher; can we forget his lectures, songs, prayers, and sermons? No never. We can imagine we yet hear his voice singing, "A Charge to Keep I Have a God to Glorify." The Dallas District has lost a great preacher. The Church and Conference a high honor. The State and Nation a good citizen. The family a great father and husband. Peace to his ashes.

After the death of Dr. Westbrooks, I appointed Bro. H. Bonton to finish the year's work, who has wrought well.

He comes up with a report equal to any man on the District propotionally to the city of Dallas, and the whole of method-



ism, while each of the pastors lowered the indebtness on the propety bought previously. Rev. Appling and the few members of Hillsboro have lowered the debt on the lot and Church at that place, where we believe they can finish it in the early part of next year which will remove the last bearer to our church in that town. There are other pastors, who have wrought well, or equal to those we have mentioned, but not hearing from their closing efforts before we had to begin our reports we could not speak for them, as those who reported their closing work. We had quite a storm at Dallas, known as the Holy Ghost, or sanctified crowd with a new doctrine claiming to have been endowerd with a new tounge, and their promise to set up an organization in which the people would not have to pay money to maintain it had the effect of creating quiet an excitement for a while, proselyting of a few members from our church, but we called the people together, and explained this erronious doctrine which put a check on their purpose to wreck our church which they boasted of doing. However they have not ceased their efforts yet. They are there now, and are saying to their followers they will not cease their efforts until have shown the people they are being led by false teachers, who are serving them only for money, while they are taking collection themselves constantly from the people. We warn the pastors every where to not allow this so called Holy Ghost crowd to hold any services in any of our churches, for they come with hellish malice, to scatter, tear, and slay. Pastorial fidelity has been all that could be hoped for. Our pastors as a rule have been loyal, energetic, and hard worked, while some of them have been toiling hard and just about half paid.

Last July, one year ago at our district conference at Brownwood, \$10.00 was raised as district mission money; \$5.00 of this money was sent to Llano to rent on old house for the people to worship in. This give them a chance to get their means together with which to buy a church lot, and today we own property to the amount of \$650.00. This little mission is up in the granite mountians. Brother Mayse has done a good work.

San Angelo. Rev. J. G. Brown, pastor. This charge has not succeeded in building the church that was planned,




but they have not lost hope, and plan to build in the near future They have paid for our church lot, and have about \$200 on hand for church building. Rev. Brown and his good people cared for our district conference to the delight of all. His report will show some conversions and two third of his benevolence raised.

Moody. Rev. E. D. McCoy, pastor. On our arrival here, we found that Brother McCoy had torn down the old church and had nearly completed a new church. Several have been added to the church this year. He brings up a round report.

Temple. Under the care of Rev. McCavines has experienced her first year as a station charge. Taking all things under consideration I think it has been a pleasant year. Rev. Cavines' report will show some improvement over that of last year.

Belton and Kellbranch has had a pleasant year under the care of Rev. A. L. Carper. The church at Belton has purchased about five lots in front of our church, which increases the value of our property at that place. His report will show some improvement over that of last year. Abiline. Rev. G. M. Mallory, pastor. Brother Mallory has worked hard this year to build a new church; he succeeded in building it sufficient to hold service. He hopes to complete the building early in the new conference year. His report will show some improvement. El Paso Charge. Rev. A D. Jacques, pastor. Rev. Jacques has his work well in hand and his people are proud of him. He has at last purchased a church lot on Myrtle Avenue at a cost of \$1200. Myrtle Avenue is one of the popular Avenues of the town. On this Avenue we have street car services every seven minutes during the week, and every five minutes on Sundays. From the present outlook Rev. Jacques will make good for Methodism for all time to come, he brings up a round report. Wichita Fall. We supplied this place with Rev. Coggswell, but he failed to go, and I ask Brother Mallory to take charge of the work and give one Sunday. We have on hand twenty dollars and seventy one cents for a church lot. No benovelence raised. Dear Bishop and Brethren. There are several new towns that we hope to enter in the near future and establish our work. Namely: Rogers, Pendeton, Clifton, Morgan, Meridian, Stephenville, Gransbury, Mineral Wells, Thourbun, Sweet Water, Colorado and Pacus. Dear Bishop, we can



count from five to fifteen members in these different towns, which would mean a great deal to Methodist in the west. The Sprirtual condition of the district is good.

We have organized Sunday Schools and Epworth Leagues in every Missi n and Circuit, and they are doing some good spiritual and financial work.

We have organized two or three Methodist Brotherhoods, but they are not doing so well.

The Ladies' Aid Society is doing great good in helping the pastors raising benovelence and doing other work.

The Woman's Home Mission Society is growing rapidly and is doing great work in the different charges. The District President. Mrs. L. E. Gilmore is pushing every interest. Mrs. Spriggs-Ratliff, our Conference Secretary deserve; much credit. Her visit to our District Conference served as an insperation to our women throught the district.

Bishop, the results of the year may seem small when compared with the larger districts, but it means much for us who labor in the West.

I have traveled many miles in the discharge of my duty, and have preached and lectured on every possible occassion. I have done my duty as far as I was able. I have helped the Brethren as best I could.




Report of the Waco District Superintendent to the Thirtyninth Session of the West Texas Annual Conference held at San Antonio, November 23, 1911.

Mr. President and Brothren; it is greatful to the Father of us all that I am spared to report to you the part of the work that you trusted to my care and too, Biship, under your authority two years ago. I received this commission I was not unminfull to the better that I afterward received beliving that 365 days make a year. A year's work could be done as such on the second Saturday and Sunday. December found me with Rev. P. B. Bennett at Groesbeck Circuit with in mind I found him with a good year's work and from there to the following, Revs S. T. Humphry Groesbeck and Kosse Bre-



mond, Reagan, and Longbranch, N. J. Moore, Calvert and Mt. Zion; J. W. Weakley, Marlin and Boman; J. H. Swann, Maysfield; Port Solven and Cross Road; Thos. Carter, Cameron and Rosebud; E. Henderson, Moorsville, Chilton and Gurley; J. W. Stone, Andrew, New Zien and Majors; W. M. Reed, Mart, Springhill and Risonson; B. J. Goff, Waco Mt. Zion; John Bickham, East Waco Circuit; H. A. Jones, Waco St. James, L. H. Richardson. This gives us the first round, every pastor at his post and seems a perfect fit; nothing but success waited them only a few exception. Rev. P. B. Bennett, Groesbeck Circuit was asked to raise \$114, and will report \$77. He has repaired two churches, and had a good revival, and added twenty to the church. Rev. N. J. Moore, Bremond, was asked to raise \$114 and has raised \$45 and added thirty-eight to the church, and done some needed repairing on his church at Reagan, notwithstanding this being his forth and best year. He leaves the church in good condition. Rev. J. W. Weakley is a hard worker and is doing his best to get Calvert to where he thinks it ought to stand; he finds his hands full, but determined to succeed. He will bring the \$120. Rev. J. H. Swann of Marlin, with some odds against him. He has done well. The church that I referred to in my last year's report, decided that they would move, so after moving, they found that the church was not what they wanted, and had to spend between \$500 and \$1000; when completed it will do in a city. The church at Marlin. That debt has been paid so I am informed. The odds I spoke off, is, some of the members do not belong to the church but in return the church belong to them, that is, they will not do what the church say, but wants the institution to do what they say, and when the Rev. told them that the church stood for prohibition, they decided against him and myself as well, and it would surprise you to know the things that they said that it would prohibit. The fight is not quite off, yet that has somewhat hindred him. Rev. Thomas Carter of Maysfield Circuit, a supply, was asked to raise \$60 and will report. He had a good revival, added twelve to the church. Brother Carter is an earnest worker, done some needed repair on the parsonage. Brother Henderson, Cameron and Rosebud was asked to raise \$60 will report forty-seven, he has not done what he thought. His church at Cameron blew down and has not been rebuilt. Rev. W. M. Reed, as usual will report all claims and raised \$119; though he was sick over three month; but one thing can be said of his people, as well as himself, a few people like them, and a few preachers like

Reed. He had a spledid revival, added twenty-five to the church, and all claims raised. Rev. J. W. Stone, Mooreville Circuit was asked to raise \$100, will report \$45. He had a good revival. Rev. Stone is a strange preacher, but there is one thing, some preachers are heard to learn that they can not pastor and live out of their work. We have two cases and each of them have tried, but failed. Brother John Bick. ham at the last conference asked that Rethleham and Union point be divided from Mt. Zion, Waco. We thought that the good brother was in his own light; but to say the least, he has raised more for himself and done more good for all causes then here before, \$73 from Waco Mt. Zion, thirty-six added to the church. He is in hope of getting back half of the property that we once owned on North-six. The people asked his return. Rev. H. A. Jones, East Waco Circuit took the new work with Bethleham and Union Point, was asked to raise \$60, and will report forty-two added to the church. Rev. Jones had a delight in building and repairing churches this year. He tore down Bethleham and moved it in a more suitable place. The lumber he had at East Waco, he turned it into a church, and will with some help from the Church Extension have a good church at East Waco. We have written to the Parent Board two or three times, they said they had not heard from us. Rev. B.J. Goff, Mart Circuit is another good and faithful servant, wherever he goes there is something doing. He will raise his full apportionment, \$88, and added a goodly number to the church. This being the first Methodist church in Mart all joined us, a great many went home so they say, but the Reverend has held his own. Our church and parsonage lot being small he bought another joining, paid some \$25. Rev. L. H. Richardson, Waco St. James is congratulated as having a system that I hope to use on the district, it would not hurt the West Texas Conference. It enabled him to raise all of his benevolent. He leaves \$800 or a \$1000 for the new St. James church, and added thirty-five members. All local debts have been paid. Mr. President, we have tried to do our duty. We find that the salaries of pastors were \$1400 short, so I got each charge to raise what ever was needed, and at the district conference all had received more, so I dont think that the different will be as much. Our benevolent, including Samuel Huston College, is \$1800, it has been our endeavor at fifty-two conferences to put the matter before them; the result is an increase over last year on all lines.

The Southwestern Christian Advocate do not have the



circulation as it should on the district. Something over onehundred papers were taken. Many of our local preachers do not take it. We had a law in the district, that should a local preacher fail, his license was not renewed. The Waco district repealed it, and since, a great many have deserted the paper. I think the law a good one, so I am hoping that we do better.

The Sunday Schools and Epworth Leagues are doing fairly well. Through the society of the church we will be able to give to our Samuel Huston College about \$400 or more. The Ladies' Aid is taken part in all the charges; but a few of the sisters think money a monument. They must save the treasure from some very needy cause, and will not let the pastor use it. I have had them to know that the pastor and officers rule the church. The cause of not using the money, is, some of the pastors would not have anything to do with the sisters and they would not have anything to do with the pastors. The Brotherhood is a thing of distant, but we are nearing it; I do not think it long before it will find its place in all the charges, not in name only, but doing what I see it can. We are trying to develop the strength that is in the Waco district with a combined force of pastors, no friction except some of the pastors want something better at the expense of their brother, which is wrong. After serving for a year with their own charge, then want to take another charge. I think they are learning fast to make the one they have what they want.

This is my second report. Having done my best, I ask the prayers of the conference.


Whereas; There is a vast Territory in the State of Texas, more North, North West and West, and even other selections of the state, laying out and undeveloped, and
