#### CONFERENCE HISTORY.

The Methodist Episcopal Church was reorganized in annual conference relations in New Orleans, La., Dec. 25, 1865, by Bishop Thompson. The Conference then organized included Louisiana, Mississippi and Texas, and was named the Mississippi Mission of Conference. Three annual sessions of this Conference were held, and in January, 1867, the Texas Conference was organized out of the Mississippi Mission Conference, which included the entire State of Texas. There were eight annual sessions of the Texas Conference held, and it was during the eigth session of the Texas Conference, held at Marshall, Texas, January 7, 1873, that the West Texas Conference was organized, with Bishop Thos. Bowman, President. The ministers comprising the West Texas Conference were called to meet in Wesley Chapel Methodist Episcopal Church in Austin, Texas, January 22, 1874. The President of that Conference was Bishop Bowman. Those present in the organization were: G. W. Honey, Jacob Miller, Mack Henson, Daniel Gregory, Samuel Allen, W. O. Sheely, Larkin Carper, Archie Johnson, J. T. Hill, T. T. Leach, T. G. Lacy, Alex Campbell, London Morris, Isaac Wright, Cyrus Hackett, Daniel Harper, Charles Scruggs. Bro. Charles Scruggs only brother alive. The rest have finished their course.

The history of this great man will never be written in full. The story of his early life was a struggle for existence. We have often heard him speak of his trials in tyring to get an education. He was born, I think, in the clay hills of Georgia. His profession was that of a teacher. Seventeen years ago he came to Texas and took charge of S. H. C. when it was in its infancy.

We only want to speak of the man. It is known both North and South, and especially in our West Texas Conference, that he made S. H. C. what it is. His constant advice to young people, also to young men preparing for the ministry, was to get an education. His advice at all times was that similar to what a senator said touching candidacy for the ministry. He said if I had but ten years to live I would spend five of those years in preparation, and hence accomplish more in five years

with a preparation than the whole of ten years without preparation.

This was Dr. Lovinggood's hobby. He died practically a young man, but each day may count for a year in deeds, as we do not live by days but by service.

His funeral was largely attended by some of the best white citizens of Austin.

Lives of good men all remind us we can make our lives sublime and departing leave behind us footprints on the sands of time. He died December 17, 1916. His motto may express his characteristics in the following lines:

"Whatever you are, be noble;
Whatever you do, do well;
Whenever you speak, speak kindly—
Give joy wherever you dwell."

#### REPORT OF THE AUSTIN DISTRICT FOR 1917.

Dear Bishop, Fathers and Brothers in the Master's vine-yard: Again the great Providential wheel directed by Him who shapes the destiny of men has rolled us to the sitting of another annual meeting of our great Conference. This sitting finds us yet in good faith—faith to the end that we can say as Paul of old, nothing shall separate us from the grand old Methodist Episcopal Church. Notwithstanding drouth, high cost of living, wars and rumors of war, we have kept the faith and held our own in many respects.

We began our work the next week after the close of the annual Conference at Waco with Rev. H. F. McKinney at Georgetown. Bro. McKinney ran well for a while, paid out \$600 on the church debts, but serious murmers came up and the people sat down on him. So much so until he and the people thought he could not overcome it. He said he had a transfer to East St. Louis. I put in charge M. W. Stevens. Bro. Stevens will report all causes presented and some improvements made on the parsonage.

#### Littig and Manor, J. F. Muse, Pastor.

This is Rev. Muse's third year here. He has rebuilt our church at Manor, which was destroyed last winter, and now they have a better church than at first, completed with little debt. His report will show an advance over last year. His people ask his return.

#### Simpson Tabernacle, J. W. Downs, Pastor.

This has been a great year for Simpson Tabernacle. They have torn down the old parsonage and rebuilt it at a cost of \$500. They have also remodeled the church and given it two coats of paint, inside and outside. His benevolence will surpass last year. His people ask his return.

# Luling, W. F. W. Brown, Pastor.

Rev. Brown has had a splendid year, with two good revivals and many added to the church. Some improvements on the parsonage and church. He will report something in advance of last year. Bro. Brown is an excellent preacher and would make a great pastor if he did not divide his energy teaching school and preaching. His people ask for his return with full time.

# Lockhart, J. H. Napier, Pastor.

This is Bro. Napier's second year. He will report something for the various causes. He has had a good revival, with several additions.

#### Lagrange, G. M. Mallory, Pastor.

This is Bro. Mallory's third year at Lagrange. He is an earnest worker and gets results. He is a revivalist and financier. Many have been added to the church this year. His people ask his return, but he desires to leave.

## Lagrange Circuit, J. L. Wattley, Supply.

Bro. Wattley, a young local preacher and student of Samuel Huston College, is supplying this place. He is a worthy young man, and will report the work done.

## Fayetteville Circuit, G. H. Baker, Supply.

This place was supplied by Rev. Baker. He will report the work done.

# Winchester Circuit, R. T. Hays, Pastor.

This is Rev. Hays second year at Winchester. He has had a good revival, painted the parsonage, paid a neat sum on the church debt at Salem. He desires a change.

# Smithville, J. H. Duddley, Supply.

Rev. Duddley has worked hard to make his report. He is a safe young man.

## Hutto, Granger and Taylor, Thos. Foy, Pastor.

This has been a great year for Bro. Foy, notwithstanding many of the people have moved away from this drouth-stricken district. He will report in advance of last year. He has painted the church at Hutto and has some money in the treasury for a new building at Granger.

## Austin Circuit, W. F. Huff, Supply.

Bro. Huff started off well, but was stricken with appendicitis and had to go to the hospital for an operation, which was

successful, but kept him in for three months. In the mean time the drouth set in and most all of his people have moved away in search of work. However, he will report something for the different causes.

#### Cedar Creek Circuit, F. J. Hutchinson, Pastor.

This is Rev. Hutchinson's third year. He will report something for each cause. He knows no failure. Some valuable improvements have been made.

#### San Marcos, W. M. White, Supply.

Dr. W. M. White has been supplying this charge. He has wrought well. His work is alive. He is a strong preacher and financier. He will report the work done.

# Wesley Chapel, J. W. Warren, Pastor.

This has been a great year for Wesley Chapel, debt paying, raising benevolent and education money, has been their chief object. They held a great revival this spring and many were added to the church. They have raised nearly half of the educational and benevolent money, which I shall report on the district. Wesley is alive.

# S. H. C., M. S. Davage, President.

We count ourselves lucky in securing this strong intellectual gentleman and his most accomplished wife to followe Prof. R. S. Lovinggood, who fell asleep in Jesus at the close of our Annual Conference last year. We miss him, but our loss is heaven's gain. But we have found in Prof. Davage all of the elements which go to make a safe and sane leader and we will gladly follow where he leadeth.

# Samuel Huston College.

The eighteenth session of Samuel Huston College opened October 1. Because of unfavorable conditions, due to the unprecedented drouth, the draft and the high cost of living,

grave doubts were entertained by even the most hopeful for the success of the present session. It was feared that the attendance would be greatly lessened, but I am glad to say that up to this time more than 330 students have enrolled. A fine faculty has been secured and the outlook for a splendid year's work is very bright indeed.

The old Dittlinger Home has been repaired at a cost of more than \$2,000 and is now being used as the president's home. The new barn and stables have been completed, new fences put up, new furniture purchased for the dormitories, music rooms have been repaired and beautifully furnished, new typewriters have been purchased for the commercial department, and numerous repairs about the building have been made. However, because of the exceedingly high cost of provisions and all other school supplies, there is danger of a large deficit unless our pastors will encourage their members to join in and make the provision rally a great success.

All of the leading schools of Texas have raised prices this year. Samuel Huston College alone stands by the people with the same prices as heretofore. But it will be impossible to avoid a large deficit unless our patrons are encouraged to pay their bills promptly and our pastors join heartily in making the provision rally succeed.

#### Eliza Dee Home.

The new Eliza Dee Home is no more a dream, but a reality. It is the best in the whole connection for colored girls. We take off our hats to Miss C. I. King and Mrs. E. S. Spuggs Ratcliff, and promise them we will stand by them in the future as we have in the past with our prayers and money. They have nearly forty bright girls in the home, and more are to come if they can make room for them.

#### The Auxiliaries.

All of the auxiliaries are alive and at work, most especially the Sunday schools. The coming of Dr. E. M. Jones to our Conference was a God send. He has touched nearly every charge in our District. Some of our Sunday schools have nearly trebbled themselves in attendance. We only regret that Dr. Jones has not come to stay permanently. Most of the Sunday schools have been graded and are doing effective and constructive work. The Epworth League and Junior Leagues are playing their part. Many have organized the Epworth Guards for the boys and the Campfire Bands for the girls. In this they are giving the young folks something to do. The Young Man's Movement, Ladies' Aid, Brotherhood, and Woman's Home Missionary Societies are at work.

#### My Work as District Superintendent.

Dear Bishop, I have traveled, preached and lectured over the district as best I could. I have striven to keep the banner of Methodism afloat, and to keep aglow the Methodist fire once kindled by our fathers at the altar of sacrifice and hard toil.

I have held and caused to be held four quarterly conferences in every charge during the year: One district conference, Methodist Brotherhood, Ladies' Aid Society, Sunday School and Epworth League convention, also one ministers' council and missionary convention in the district.

# REPORT OF D. C. LACY, DISTRICT SUPERINTENDENT OF DALLAS DISTRICT.

Dear Bishop and Brethren: I started my work immediately following the adjournment of the last session of the Conference at Waco one year ago, and I have kept constantly, persistently, and I hope, consistently, at it up to this good hour, not leaving any word unsaid which I thought ought to be said, any act undone which I thought ought to be done, and I have had the co-operation of the men on the district without a single exception.

I wish, however, to state again plainly today, as I have said from year to year and from time to time, that the only drawback, if any, on the Dallas District this year has not been the world war now being fought on the eastern and western shores of Europe and other parts of the world between central and allied powers, including our own country; it has not been the high cost of living nor the drouth which has afflicted all of the territory within the bounds of the West Texas Conference in greater or less degree, but it is, in my judgment, the neglect of the — element in good success—the time element. I have always contended that to do a full year's work means twelve (12) full months, or three hundred and sixty-five full days. Time, time, time, waits for no man. A stitch in time still saves nine. And I am sure that if each of us would work from the time we adjourn until we meet again one year from now that our report would come to the expectation of our great church.

To speak briefly, I shall call your attention to the following, which was the plan of our work for the year:

I.

We met in what is was pleased to call the preachers' and laymen's council of Dallas District at Waxahachie January 10 of this year and laid out our work along six different lines of church endeavor: The material or temporal, educational

work among the young people, benevolent, social, and spiritual.

The temporal work in the district has by its very nature fallen under church improvement. The following charges have gone straight forward:

At Ennis and Ferris the Rev. S. N. Harvey and his good people have now in process of erection one of the best frame buildings in the West Texas Conference. They have worked hard to have the church finished by this session of the Conference. But on account of the scarcity of labor, and especially carpenters, they have not yet completed the church, but hope to enter early in January, 1918. This church brings up a good report, having paid pastor and district superintendent in full.

Rev. Appling, at Sherman, and his people, have kept up the monthly payment on our beautiful church in Sherman. This was built last year. He brings a fairly good report financially.

Rev. J. H. Qualls has led his people well. They have paid a nice sum on the church debt at Hubbard.

At Pelham, which is one of our best circuits, Bro. Moore brings a good report, almost 1,009.

The church at Antioch was blown to pieces in May, but by tireless effort and with the help of the Church Extension Society they have rebuilt the church.

Rev. J. W. V. Hutchinson has caused some much needed/improvement at Denison. He brings a good report.

This year Bro. Duncan has done some much needed work in seating the church at Milford.

Rev. J. N. Hooey has planned to move our church at Lancaster to a much better location and purchase a lot for \$200, and has paid \$100 down.

Rev. Norris, who supplied North Dallas and Queen City, has done some much needed improvement.

Rev. S. D. Humphrey has done what he could under the circumstances.

Rev. Brown, at North Fort Worth, brings a good report, as is his custom.

Rev. A. L. Carper has done a good year's work in paying

the notes on our property at St. Andrews, Fort Worth. He brings up a good report.

Rev. J. W. Weakley, at St. Paul, is a good pastor and faithful shepherd. His report this year, all around, is the best he has brought since being assigned there four years ago. They worked hard to get into their 12-foot basement by this conference, but untoward conditions caused them to fail. But they are planning to enter this winter or by early spring.

#### II. Educational.

We have work to get all old students to return to Samuel Huston this year and as many new ones as possible. Bishop Shepherd, of the Annual Conference at Waco last year, said plans had been laid by the Superintendent of Austin District.

We were not startled to learn of the demise of our hero, big brother and councilor, the late lamented and much beloved president, R. S. Lovinggood, A. M. and P. H. D. We are justly proud of our new president, Prof. M. S. Davage, A. M. We thank profoundly the Free Aid Board for his selection as president of Samuel Huston College. A workman falls but the work goes on. We have tried to show the board and Prof. Davage how we apprecite them by bringing up the largest amount up to date from Dallas ever brought before—\$800—which is 100 per cent above what we brought four years ago.

#### III.

Our people have been looked after through the Sunday Schools and Epworth Leagues. Dr. E. M. Jones, our field secretary for Sunday Schools, was with us during the spring, and I think spent time enough to hold institutes in every charge save possibly one or two, bringing new and live ideas to the Sunday School. Quite all the charges have raised full assessments for the Sunday School Board. These schools raised for Samuel Huston College more than \$300, as also did the Epworth League chapters raise \$340.

When I made report to the District Conference at North

Fort Worth last summer I tried to put much stress upon three claims which the Dallas District, and possibly the West Texas, as a whole, seem to look upon as side issues, namely, the Conference claimants, the general Conference expenses, and Episcopal fund. I hope we will see the wisdom of our effort by advanced report on these claims, and I wish to say here, as all of us will see when the Conference Board renders their report, that the General Conference held at Saratoga, N. Y., has made such legislation as will put all of the backward Conferences more and more upon their merits. Therefore we, as a district, tried to lay our work so as to do our part toward our Conference Claimant Endowment Fund.

Next, we have done our best to do our part of the world's work in the form of social and moral uplift of our people, endeavoring to show them by precept and example the great need of frugality, encouraging them in buying and purchasing homes for themselves. It is not generally known that 75 per cent of the poorly paid preachers of the West Texas Conference either own their homes or are buying them. This is a much better showing than any other class of citizens of this state, among the colored people. The benevolence of the churches in the Dallas District is considerably increased over last year, totalling hundreds of dollars. The larger churches even proportion have done. We have kept steadily before the churches the motto of our efficiency conference held at Samuel Huston College, in Austin, nearly two years ago. All churches and parsonages have been beautified and painted, all church debts canceled, and 5,000 suls added to the membership during the present quadrennium. Last year we made over 109, and over this year we have added.

I think, however, that our gain this year has been at the expense of other churches. That is to say, that these additions were of people who moved to our part of the church from other churches. However, I wish to say that the revivals have not yet gone out on Methodist altars. I wish to close by saying that while the modern exodus, as Dr. Melden, of New Orleans University, calls it, of our people northward, the young men who have been called to the front on account of the great

world war, the churches in North Texas, and especially the Methodist Episcopal churches of the Dallas District, have held their own.

I am your yoke fellow and co-laborer in the cause of the Master.

# Report of T. H. Wyatt, District Superintendent of the San Antonio District of the West Texas Conference, at Cuero, Tex., December 12-16, 1917.

Dear Bishop and Members of the West Texas Conference, now in session: By the appointment of Bishop Cooke, this, your humble servant, and the brother pastors of the San Antonio District, went to our different fields of labor without murmering or complaining, and we have worked together for another year in the Master's vineyard.

We thank our Heavenly Father for the lives of us all. Not one man of us has fallen at his post of duty, but we are all here at the bar of this Conference to answer to our names and to render our reports, to let this Conference know how we have labored and fought as soldiers of the cross side by side. How well we have done our duty, our several reports will tell. December 30, 1916, we began our work for this year with Rev. W. M. Mooney at Cuero. This has been a great year for Rev. Mooney in this work. He had a great revival that stirred this whole town, in which both old and young were converted. It was the greatest revival of his six years as pastor in this charge in many ways.

He raised all of his Samuel Houston College assessment and is far in advance of last year with his general benevolence. He made some needed repairs both on the church and parsonage, and comes up with a good report. His people petition and ask for his return for another year.

We next meet Rev. J. H. Hutcherson and his people at Gonzales and Elm. I found Rev. Hutcherson planning and working hard, starting out well as pastor of this charge for the second year. He has kept faithfully at his work all of this year. Had several converts, raised all of his Samuel Houston

College money, and comes up with the most of his general benevolenc.

January 13-14, 1917, we met Rev. C. H. Franklin and his people at Hood. Rev. C. H. Franklin has labored hard this year at Bishop, yet he has been unable to get his people to work as he did the first year he was with them. This is one of our largest rural charges in the San Antonio District, and much could be expected of Hood, if we can find a man who can lead that work out. Rev. Franklin's report will show what he has been able to accomplish for the church this year.

We next meet Rev. J. J. Hardiman, who had been only a few days on the ground on the Smiley Circuit, but he had things well in hand. He has looked after departments of the church work, and his report will be one of the best that ever came from this circuit. He had a good revival and raised all of his Samuel Houston College money and comes up with his general benevolence.

Our next stop was with Rev. G. V. Cavit and his people at Nixon. This brother has put in a hard year's work and has therefore succeeded. Had a fine revival with several converts, added many to the church, raised all of his Samuel Huston College money and comes up with his general claims. He also entertained one Ministerial Council in April, which was quite a success. Bish, Rev. Cavis has succedeed well in all lines of his rural work.

We then left Rev. Cavit's work and met Rev. A. M. Mason at Jacob Church, San Antonio. Bishop, although this brother's wife has been sick all of this year and at times we did not expect her to live, yet Rev. Mason has been able to pay off all but \$40 that stands against our church property, cared for the District Conference, raised all of his Samuel Houston College money and comes up in advance of last year with his general benevolence.

February 17 we were at Floresville with Rev. A. Brown and his people. This was Rev. Brown's third year as pastor on this charge, and it has been the best of the three. Rev. Brown knows and loves the Methodist Church and never tires working for the same. He is always up and doing. Had a good

revival, raised his Samuel Huston College claims and comes up with his general benevolence.

We then met Rev. I. T. Sanford and his people at Beeville. This brother started off fine in this charge and his first Quarterly Conference was quite a success, but his parsonage burned in April and this has greatly hindered him in his work. He has been able by hard work to put up a fair building on the same spot of ground. His report will tell for itself the work accomplished by this pastor and his people for this year.

Kingsville was our next place to visit, and there we found Rev. J. B. Eggleston on the ground and hard at work. From the first of the year, Rev. Eggleston started off in his work with a revival which was a great success and caused him to get into the hearts of his people. He had a great number of converts, raised his Samuel Huston College money, his general benevolence and built for Methodism the best meeting house that we ever had in Corpus Christi. This brother has also been recommended by the district to this Annual Conference for admittance on trial.

We next met Rev. L. H. Richardson and his people, in St. Paul, the leading charge of the district. This year has been the climax for Brother Richardson in this charge. Every department in this charge has done a good year's work. He had a great revival and many converts. More than 200 joined St. Paul this year. He has raised \$1,250 for the building of a new church, raised all of the Samuel Huston College money and comes up with his benevolence claims. He has had a great year's work. The Quarterly Conference asks for his return for another year and petitions the Bishop and Cabinet also for his return.

February 19 we met Rev. N. H. Townsend at Kerrshill, San Antonio. Bishop, the cabinet sent the right man to this charge. Rev. Townsend has put in one of the best years of all his ministry in this work. I need not tell this Conference, Bishop, wherever this Conference has sent that brother he has always come back to the next Annual Conference with a round report. He has done as usual. He has raised all of his Samuel Huston College money and all of his general benevolence and

greatly reduced the debt that stands against the church property. His people unanimously ask for his return as pastor for another year.

We next met Rev. I. H. Timmons at Kenwood, San Antonio. Bishop, Rev. Timmons has had a hard year of it. He gave a great part of his small salary to help pay off the debt against the church property. He had a good revival and with 36 members he brings \$40 for general benevolence. Under the conditions under which that pastor has labored, he has succeeded well. His wife has been sick all this year, and that, also, has taken much of his time from his work, and yet he has done the work of the church well.

We next met Rev. L. W. Roberts and his good people at Pleasanton. We found him and his family on the ground and hard at work. He has kept at it all of this year. Every Sunday was a revival day on this work. Many were converted in the regular service, or in other words, more converts have been made on this circuit this year than any other year of its history. He comes up with a good report and his people asks for his return as pastor for another year.

Our next stop was with Rev. C. Hampleton and his people at Pearsall. This brother has succeeded far beyond my expectation. He had a good revival and added several to the church, raised his Samuel Huston College money and this work that did not give this Conference one cent of general benevolence last year will come up with all of its claims this year.

We then met Rev. W. M. Ellerson and his people on the Hampleton Circuit. Bishop, from the very beginning, Rev. Ellerson and his people got down to work, and have kept at it all this year. There are no slackers in his official family—they are all workers. This has been the best year of Rev. Ellerson's ministry. He ran an old-time camp meeting, where he and his people went out in camp and prayed, sang, preached and worked day and night. The result was they had 112 converts and added more than 130 to the church this year. He raised all the Samuel Huston College money and comes up with a round report. His people paid him his full assessment two

months before Conference and has kept on paying him. They ask for his return as pastor for another year.

At Gonzales Circuit we found Rev. T. G. Walker and Rev. Hutcherson also in a camp meeting. While they did not succeed in having as many converts as Rev. Ellerson had in his camp meeting, yet they did good in many ways. This brother has worked hard. His people failed in crops and hence left and went hunting for work. He has had a few to labor with and will come up with a fair report.

We then met Rev. Ben Williams and his people at Lavernia Circuit. Rev. Williams has had a very, very hard year of it, and yet he stayed by his work and worked hard. He had a good revival, and has succeeded in putting in the town of Lavernia a church house for Methodism. Rev. Williams will also bring up three times as much of general benevolence as we got from this circuit last year. He comes up with a good report. The District Conference Recommends him to this Annual Conference for admission on trial.

March 12 we were with Rev. J. C. Eusan at Yorktown, where he has served the people about 14 years. In fact, they do not look for any other pastor but Rev. Eusan at Yorktown. He had a good revival, raised all of his Samuel Huston College money and also all of his benevolence, and his people ask for his return as pastor for another year.

March 5 I met Rev. T. J. Carper and his people at Seguin. This has been Rev. Carper's sixth year with this people. He had a good year of it. Had a good revival as usual, raised his Samuel Huston College money, and comes up with more general benevolence this year than last. His people ask for his return.

On to Hondo. There we met Rev. J. D. Mackey out in the Far West. Bishop, this brother has done a great year's work for the Master and Methodism. He had several revivals this year, which resulted in many conversions; about doubled our membership in this work; organized two new preaching places this year and has made Hondo one of the best circuits on the San Antonio District. He raised his Samuel Huston College

money and comes up with his general benevolence, and the people ask for his return for another year.

At Southerland Springs we had Rev. Joe Young as pastor. We used this brother as a supply. He has done a good year's work. He had a good revival, raised his educational money and comes up in advance of last year with general benevolence from this circuit. He has succeeded beyond all expectations.

We closed out our first round with Rev. J. W. Stone, Jr., at Kerrville, also in the Far West. This brother has had sickness in his family nearly all of this year, yet he has led this work to its highest water mark. Rev. Stone, Jr., is a hard student and a hard worker, hence he has succeeded. He had a good revival, raised his Samuel Huston College money and comes up with his general benevolence. He makes a good report.

Dear Bishop, I have been in every charge in the San Antonio District. Shared with my pastors in their bitters and their sweets, and advised and helped them and the people with all of my ability and the power that I had in me. Held and caused to be held four Quartely Conferences in each charge. Preached and lectured to the people 347 times this year, travelled 13,591 miles in the discharge of my duty as District Superintendent in the District.

We have had 746 converts in the district and added more than 1,000 members to the different churches and built six new meeting houses and a parsonage in the district. Held one profitable Ministerial Council in the district, in which we planned the camp meetings and revivals that we had this year. Also planned how to raise our general benevolence. We held also one District Sunday School and Epworth League Conference and District Conference, in which we raised for Samuel Huston College and the Eliza Dee Home \$1,259.

W have organized a District Economical Convention, with each pastor to organize a local Economic Club in his Church. We have held meetings on the conservation of food in several places in the district. In fact I like my work, Bishop, and take great pleasure in helping the pastors and people in every way that I can.

We have a band of working young people who take great

pride in raising money for Samuel Huston College. We have over 2,500 young people in the Sunday School and over 1,775 at work in the Epworth League, making a grand total of over 4,275 young people at work somewhere in the Church. We are trying to make these young lives count for something in the work of the Master.

We have 42 young men and women of the district in Samuel Huston College. We stand by the school with our money, young people and other means. We are to have a great Samuel Huston College pound party and watch night all over the district, and all that is given will be sent to the Samuel Huston College as a New Year's gift to help the school out during these hard times..

Bishop, in every charge in the District we have also Samuel Huston College garden clubs and the club that brings the most or the highest amount of money to the District Conference for Samuel Huston will be given the privilege of naming a two-month scholarship in Samuel Huston College. But all the money that is raised in all the clubs of the District will go to Samuel Huston College.

We are trying to help in a great measure to take care of our own.

While this has been one of the hardest years for our work, short cross and people moving from the district, the high cost of living—all these things have greatly hindered our work, but have not made us fail, for we have succeeded on all lines and stand far in advance of last year.

I have no excuse to make for myself or my men. We have labored hard and hence we have been able to do something for our heavenly Master and the church.

Dear Bishop and Brethren: We are grateful to our heavenly Father for this our second year's opportunity to render

Also the government is co-operating with church, state and municipality in wiping out the immoral institutions of our land and putting our nation on a safer basis. We are trying to fully realize that we are instruments in the hands of God and must take our share in bringing the kingdoms of this world to Him. Hence we are thankful to be present to make our annual report.

#### From the Field by the Charge.

Brownwood and Brady, Rev. S. G. Graham, pastor—Brother Graham went directly to his work from the Conference and began in earnest. He did a good year's work. He had splendid revivals, with several conversions and accessions of young and older people. He paid some on the church debt, raised \$40 for Samuel Huston College and \$51 for general benevolence. Our next District Conference convenes there. His people asked for his return.

Liberty Hill Circuit, Rev. R. Alonzo, pastor—Brother Alonzo has served his third year. His good people have co-operated with him in all his plans and efforts—hence he has a good report. His work covers a part of four counties. We are changing the map of some of the work, that better results and a more direct access may be had. He raised \$40 for Samuel Huston College and \$54 for general benevolence. Brother Alonzo is thoughtful, brotherly and fatherly in all his efforts.

Lampasas and San Saba, Rev. J. S. Medlock, Pastor—This is Brother Medlock's first year. He has made good. Also he and his people at Lampasas are planning a stone church house. The stone material is already purchased. He had good revivals, with several conversions and accessions. He made a good report at the District Conference and brings good reports to the Conference. He and his people are doing work agreeably.

Temple, Rev. M. L. Wyatt, Pastor—Brother Wyatt is a good preacher, a good, congenial pastor, and a splendid financier. He and his people have done a lovely year's work. He has about finished paying for the new church site, raised \$100 for Samuel Huston College and \$45 for general benevolence. His people are more than anxious for his return. His wife is a splendid helpmeet, sharing all interests with him.

Bartlett and Davilla, Rev. J. M. Foster, Pastor—Brother Foster and his people have done nicely. The church lot at Bartnett is paid for and they are looking forward for a new church building. This circuit is in the center of the drouth stricken district. Yet he brings up a good report for Samuel Huston College and some benevolences.

Moody and Rogers—Rev. C. H. Anderson closes his second year's work. Brother Anderson and his people have wrought well. He has made some improvements on the parsonage, paid a note on the church debt, raised \$84 for Samuel Huston College, and something for benevolences. Because of drouth no progress has been made at Rogers. Brother Anderson is a safe young man.

Belton and Kell's Branch, Rev. Geo. W. Nevils, Pastor—Brother Nevils came to his work with his peculiar determination, that is to succeed. He built a new parsonage worth \$1,250, had good revivals with a goodly number of conversions and accessions. He and his good people cared for the District Conference in a very credible way indeed. He is a good preacher and an energetic and industrious pastor. He knows no failure.

Gatesville and Valley Mills, Rev. J. E. Brown, Pastor—Brother Brown has closed his seventh year; yet his people want him to return. He had good revivals, gained many souls for the kingdom. He brings a good report but wishes a change.

Cleburn and Alvarado, Rev. E. C. Henderson, Pastor—Brother Henderson has served his second year. He has made some improvementss over last year's report. Brother S. C. Coleman has donated a plot of ground to the church for a building site. This place is on a beautiful hill just one mile from the city. Thirty-five families of our people own homes on this hill. No other church is located there. We shall do the conference great credit to assist in building up there. He has raised about \$50 for that purpose. We are asking for a donation for building purposes.

Abilene, T. C. Butler, Pastor—Brother Butler and his people started off in good spirit. By some means they became separated and the result was brother left the work because of non-support. I used every good grace to relieve the situation, but to no effect. Nothing immoral, but they did not agree to work together. Brother Butler sent no report to the District Conference. In August I supplied the work with Brother C. E. Ware. He took hold with interest, paid several claims

in full, and put the work on a splendid footing. The people want his return.

El Paso, Rev. V. A. Cooke, Pastor—Brother Cooke comes to us from the Central Missouri Conference. He was highly recommended. He is a graduate from Tuskegee and also the Gammon School of Theology. He has done a great year's work. We went with him from Waco and gave him a first-hand knowledge of conditions. At the meeting of our First Quarterly Conference in March we gave him special assistance—a special request of \$639—we raised \$706. He has a splendid grip on the city and his people, and brings a good report both for education and general benevolences. His wife is a splendid character and of special training. She has done great work right by his side. The church and people wish their return.

San Angelo, Rev. G. W. Wormley, Pastor—Brother Wormley has done a good year's work this year. He had a good revival with excellent results. He did fine for Samuel Huston, made a good payment on our debt, and brings a good report on general benevolences. He spoke of making a request of the Conference and Bishop to be left without an appointment to take a year or two rest. He has labored incessantly for 32 consecutive years. In due time he will speak for himself.

#### New Work.

We have embraced a new problem. Our membership is now scattering as never before. Some are going north, some into New Mexico and Arizona, and California, and still others in different little towns, villages, ranches and cities in the Middle West. Hence there are several new phases coming into prominence because of these emigrations. There are Alpine and Marfa, on the S. P. R. R.; Sweet Water, Big Springs, Pecos, Toyah and Colorado, on the T. & P. R. R.; Crawford, Clifton, Meridian, Morgan and Ballinger, on the Santa Fe, and Eddy, Troy, Holland and Cooks Chapel on the Katy, and Thurber, Eden and Dublin on the Frisco. These and other places loudly tell us that we need more men and money on the field.

Many of these places have neither church nor school of any kind. "The harvest is waiting but the laborers are few."

Bishop and brethren, we would have accomplished much for the Master if we could impress the Conference powers that they give us more good active men and money to back them up. More prayers, more men and more money.

#### My Labors as District Superintendent.

I have endeavored to encourage all the district organizations and auxiliaries as well as the local, and they are doing progressive work in their peculiar line of service.' They are becoming more and more potent in stimulating financial interests throughout the district. More money was raised for Samuel Huston College than ever before. Our District Conference was largely attended, and we were honored with the presence of Dr. E. M. Jones, D. D., field secretary of the Board of Sunday Schools, and whose labor is having a telling effect upon our Sunday Schools, and Dr. G. Garland Penn, who brought greetings from the Freedman's Aid Board and spirited us up in our Lovinggood Memorial Building Fund campaign, and also our new president, Dr. M. S. Davage. We know of Prof. Davage in college, General Conference and throughout Methodism. We are doubly assured that Samuel Huston will take no steps beckward, but because of the sacrifices of the late and lamented President Lovingood and the stalwart and far-seeing leadership of our new president, Davage, we shall move onward by leaps and bounds. We have the utmost confidence in his success.

I have traveled 13,308 miles upon the district. Have held and caused to be held four Quarterly Conferences in each charge and on each circuit; held one District Conference and one District Woman's Home Missionary, Ladies' Aid, Sunday School, Epworth League and Methodist Brotherhood Convention and one District Ministerial Council and Missionary Convention.

I preached 165 sermons and lectured 127 times in Sunday Schools, public schools, etc., and distributed three dozen dis-

cipline books and pamphlets of Epworth League literature and other reading matters and church literature that gave life and light to the young people. I have tried to help all the pastors and people in every charge by way of advice and personal service. I have put myself unreservedly upon the altar for service and effective work.

We are poorly paid, so far as salary is concerned, but we are, nevertheless, loyal and faithful. We can be depended upon to do our whole duty as men who must give an account of their stewardship to the Redeemer and Savior of mankind.

## Spiritual Conditions.

Good revivals have been had in nearly every charge and circuit on the district, and through them many precious souls have been led to Christ and added to the church.

The spiritual needs of our people are carefully guarded by these faithful pastors of the district.

# New Churches and Improvements.

Rev. Albert Sanford and his good people have succeeded in building a neat frame church at Altair.

Rev. A. D. Rice, of Sublime Circuit, has built a neat church at Greensville and remodeled the parsonage.

Rev. E. L. Warren, of Wharton, has built a meeting house at that place which is a credit to Methodism.

Rev. Burnett Byars, of Weimar Circuit, has succeeded in building at Weimar.

Rev. J. W. Stone, of Yoakum, and dear people, have erected one of the best frame meeting houses in the whole Conference.

Rev. H. A. Jones, of Edna Circuit, has repurchased our property at Edna and paid five hundred dollars on the same.

#### Report of District Superintendent, Waco District.

Mr. President, dear fathers, and brethren, I am very grateful to our heavenly Father to have the privilege to submit to you my second annual report as District Superintendent of the Waco District.

At the close of our last Annual Conference, I entered upon my task with prayer and faith, believing the Lord would give us the victory. We have had death to enter our ranks and claim two of our ministers who had just retired. Rev. J. S. Wyatt went to his reward December 24, 1916. He died at his post, in full triumph of faith. Truly a good man has fallen, an ardent soldier of Jesus Christ has gone to his reward. On October 24 Brother John Bickhim answered the summons and went to his reward. These brethren were active to the last. We bow our heads to the will of God, and say brothers sleep on, we will all soon be there. I began my work immediately after the conference, December 23-24, at Grosebeck Circuit. Rev. J. W. Wright is pastor. This is his first year. Brother Wright and people are together. He is a safe leader and has done well, as his report will show all claims looked after.

Cedar and Frosa, Rev. C. B. Melton pastor. He will make a fair report, all things considered.

Groesbeck and Kossee—Brother Baker, a local preacher, was placed there as a supply, and on holding my first Quarterly Conference, the congregation felt his (Baker's) inexperience would mean their defeat in a town of strong opposition.

Rev. S. E. Jones, superintendent of Austin District, and I exchanged men, Brother Baker going to Fayettsville and Rev. Moses Smith came to Groesbeck and Kossee. Rev. Smith has proven the man for the place and at the right time. The work has doubled its contributions for all causes over the previous year, as his report will show.

Bremond Circuit, Rev. B. J. Goff, Pastor—He has done well. Rebuilt our church house at Bremond at a cost of \$900. This is where the storm tore down our meeting house three years ago. The present one is modern, neat, well ventilated and lighted, excellent pews, purchased from the Methodist Church South. Present debt is less than \$400. Had our crops matured all would have been paid. He brings a good report, as usual.

Calvert and Mt. Zion, Rev. A. Johnson, Pastor—He and his people have had a successful year. Our Methodism is alive in Calvert. All claims presented and partially met, as his report will show.

Maysfield Circuit, Rev. P. B. Bennett, Pastor—Brother Bennett and people have built a splendid parsonage and paid for same save a little. The drouth kept this from being paid—no crops and the people scattered to seek a livelihood. He will make a respectable report all things considered.

Marlin and Bowman, Rev. E. L. Jackson, Pastor—He has not done so well financially. The drouth caused his congregation to leave their homes and seek work elsewhere in the cotton fields, but the first of the year he conducted a great revival; many souls found Christ; quite a few of them joined our church. Brother Jackson entertained our District Conference Sunday School, Epworth League, and Woman's Home Missionary Convention, said to be the best in the history of the district.

Mart Circuit, Rev. N. J. Moore, Pastor—He and his people have had a good year. Revivals were held over his circuit, and a new church edifice erected at Spring Hill worth \$1,000. Paid for same save \$275. It is well ventilated, painted, clean and cozy. Mr. President, I urge my people to build plain, neat meeting houses and to beautify them, in our rural work.

Brother Moore will report a good year's work. He deserves promotion if the place can be found.

Cameron, Rosebud and Lott, Rev. Wm. Reed, Pastor—He is one of the pioneers of the Conference. He never fails, for he is no slacker—gets on the job and stays and brings things to pass. He was granted one Sunday in each month to hold services in the Missionary Baptist Church in Lott. He got his little band of faithful few together, planned a rally and at the close they realized \$250. They have purchased a beautiful site for a church building for \$150 and paid for same. I have the deed. They have \$100 in the bank for building. They earnestly request that Lott be given consideration in distributing the extension fund of this Conference. Our property at Cameron has never been clear of debt until now. This veteran minister planned one rally, raised \$229, and cleared all debts of long standing, which saves our property in Cameron. Last year Brother Reed underwent a severe operation. This has impaired his health very much. But he has done his work well this year, as his report will show, and having given the church 36 years of active service, he desires to honorably retire.

Chilton and Mooreville Circuit, Rev. R. D. Dennis, Pastor— He and his people have enjoyed another year of real good work. Brother Dennis is a safe leader and a good pastor. He reports in advance of last year for all causes.

Brack and Majors Circuit, Rev. W. W. White, Pastor—He has paid a good portion of the church debt, pushed the claims of the church and reports in advance of last year on all claims.

East Waco Circuit, Rev. J. H. Childs, Pastor—He and his people have taken care of the quarterly payments on their church debt very well,, and finished ceiling the meeting house at Bethlehem. This community was storm stricken in the month of May. All their crops were destroyed. Brother Childs gave great aid to them. He assisted in getting up the wrecked buildings and helped in getting seed to replant the cotton crop, from which they got an abundant yield. His report will show well done.

Waco, Mt. Zion, Rev. W. H. Purnell, Pastor-He and his

people have pushed all claims of the church far in advance of last year, as his report will show. He desires a better place, Bishop, if you have it to give.

Waco, St. James, Dr. P. A. Deslands, Pastor-Brother Deslands and members have accomplished much this year. They have built a beautiful modern two-story parsonage, equipped with electric lights and water. It is given up to be the best home for a pastor in Texas among our colored Methodism. They owe but little, considering its value. The insurance for \$3,500 is paid up for three years. We need more comfortable parsonages for our ministers and families. We hope to get them soon. The entire benevolences are greatly in advance. Their next and great task is to build a house of worship, which is greatly needed. We must have a new St. James or go out of business in Waco. Mr. President, I have striven to be of help to my brethren and the members. I have lectured, preached, and labored to have my people awake to the condition which confronts us Christians as a race, in the great church of our choice, our duty to God and to mankind, to rise and play our part as men in these perilous times and above all have a consciousness of right. Christ, nor the church, cannot use slackers, any more than our great government in this mighty crisis.

I have held and caused to be held four Quarterly Conferences in each station and circuit, held one District Conference, and Sunday School and Epworth League Convention, and one Layman and Ministerial Council. Our Sunday Schools, Leagues and other auxiliaries are in a very healthy condition throughout the district.

Mr. President and brethren, truly we are in the midst of a great war, a national conflict for democracy. Thus far, according to age limit, I have not been called to the front in this conflict. But the cause of Christ and the Methodist Episcopal Church called me to arms—of duty to march in front of the Waco District.

I have stood my ground for Christ and the church amid the things with which we had to contend—war, hard times, drouth and short crops—behind which many try to hide. We routed them, and when the smoke of indolence and cant and indifferent members had cleared away, these are the spoils gathered from the field of the Waco District by the earnest, hard-working and poorly-paid Christian ministers who have stood the test of another year and brought the laurels home, namely, conversions and accessions upon the district, 370, and benevolent collections.

# Board of Home Missions and Church Extension.

The last General Conference at Saratoga made some radical changes in this organization. However, it does not affect the administration of the money. I think 25 per cent still goes for church extension alone and 75 per cent goes for home missions. We mean by church extension, building churches or loaning and donating money for this cause.

Brethren, please forgive Brother Brown, as I am somewhat old fashioned, you know, for speaking his opinion concerning the Board of H. M. and C. Extension. If there ever was a benevolent board that both pastor and people should stand by it is this board. What is the use of telling you what it has done and is doing? Mind you, I am talking about myself. I expect to do my best for Samuel Huston College, as I have always done, but I shall not do less for the Board of Home

Missions and Church Extension. There is no way out of this confusion only by the rule. We have a rule: If we raise all of our apportionment (which few of us do) then the matter is easily remedied, but when we don't we say, well, I'll give the board so much. Then it looks so small we pinch off a little more from the bulk. Think of it brethren, our Conference raises every year six to seven thousand dollars, not including ministerial support, as that is not a benevolence. That is a whole lot of money. Suppose this money was divided by the per cent division? By not doing so some of our boards suffer. Or in other words, e we come very near reaching the water mark in totals. But if it was proportionately divided no board would suffer. The board asks the church for the sum of \$1,650,000, about the small sum of 50 or 55 cents per member: Whereas the Board of Home Missions and Church Extensions has done so much for our Conference,

# The Work of the Board of Education of the Methodist Episcopal Church.

(West Texas Conference.)

1. The Board of Education was established fifty years ago. The Jubilee program, including the board's appeal for one million dollars permanent endowment, the income only to be used to aid needy and deserving institutions to meet their current expenses and to supplement pensions provided by the individual colleges for their retired professors, commands our enthusiastic support. Already, under the board's leadership, in recognition of this Jubilee Anniversary, Methodist colleges and schools have added nineteen millions to their endowment and requipment. Marked progress has been made in other directions. There was a gain of more than 7,000 students during the last quadrennium.

- 2. The Student Loan Fund, derived from free-will offerings on Children's Day, the oldest of the board's activities, has assisted 25,000 Methodist boys and girls to secure an education. Two thousand and sixty-two students were aided last year. Eight students attending schools of the church whose homes are in this Conference were granted loans from Children's Day Fund, the total amounting to \$195. The total contribution last year from this Conference to the Children's Day Fund amounted to \$59, as compared with \$4 of the year before. Loans amounting to \$400 were granted to eight students in Wiley University. Loans amounting to \$125 were granted to students in Samuel Huston College.
- 3. The Aid of Institutions Fund, derived from the Public Educational Collection and Special Gifts, through which the board helps struggling institutions in the Highlands of the South, on the western frontier, and schools in peril in all sections, is of ever increasing service. Inaugurated only in recent years, this foundation laying has produced results of supreme significance. Where opportunity is well-nigh measureless, no charge should fall short of meeting its apportionment.
- 4. The Department of Religious Work cooperates in the conduct of evangelistic campaigns; devises and promotes an organized program of religious effort and practical Christian service on the college campus; and, in cooperation with the Board of Home Missions and Church Extension, has successfully begun the work of caring for Methodist students at State institutions, according to the plan approved by the General Conference of 1916.

- 5. Through its function of Counselor and Administrator of University Senate legislation the Board of Education helps to maintain high standards of scholastic work in our church institutions. It serves as a general clearing house of educational information and inspiration for the entire church, publishes reports and significant articles in the church papers, quarterly magazine, The Christian Student, and annual program for Children's Day, and an extensive leaflet literature.
- 6. Your committee recommends that this Annual Conference pledge renewed cooperation and loyal support to our Board of Education.




