PART III.—DAILY PROCEEDINGS

FIRST DAY—MORNING SESSION

Opening: The Sixty-first Session of the West Texas Annual Conference opened in St. Paul M. E. Church, Dallas, Texas, October 16-20, 1935, Bishop Robert E. Jones, D.D., president.

At 9 o'clock Bishop Jones took his seat and the conference was called to order.

It was a beautiful day and the spirit of the conference seemed fraught with the same spirit and temper as was the day.

Devotions were conducted by the bishop. Music was furnished by St. Paul M. E. Church choir.

The bishop's timely message was followed by the calling of the roll. Ninety-eight men responded to their names; others reported later.

Three had answered the roll call in glory; Revs. J. W. Stone, Jr., L. W. Roberts, and C. S. Williams. As their names were called the conference stood and the bishop led in prayer.

Organization: On motion of J. W. Warren and others, W. W. Baker was elected secretary. He named as his assistants, C. W. Franklin and J. L. Watley. They were approved.

C. E. Whitiker, treasurer, named for his staff: G. A. Deslandes, J. J. Hardiman, Z. W. Holmes, A. D. Jacques. They were approved.

F. D. Young, statistician, named his staff: B. A. Byars, R. W. Allen, J. W. Wills, J. F. Muse, Joel S. Jordan. They were approved.

Limits of the conference were set to complete a circle back to the second post in front of the rostrum.

The printed program was adopted with minor changes.

Rev. J. W. Moore was approved as reporter. List of standing committees were read—not approved.

The names of the following district superintendents were called: T. H. Wyatt, Austin District; K. W. McMillan, Dallas District; J. W. Warren, Waco District; H. A. Jones, Victoria District. They were passed in character and made their reports. This was done in open conference.

G. A. Deslandes was called, passed in character and reported the work from the San Antonio District, finishing the unexpired term of C. S. Williams.

This was strictly done in open session of the conference.

The effective elders were called on the Austin District, Dallas District, San Antonio District, Waco District, and Victoria Districts, and passed in character. This also was strictly done in open session of the conference.

Introductions: Dr. M. L. Vaughters, American Bible Society, Dallas, Texas; Rev. P. D. Saddler, pastor A. M. E. Church, Dallas, Texas; J. C. Stripland, district superintendent Palestine District, Texas Conference; Rev. E. L. McAllester, Dallas, Texas.

Question No. 40 having been asked, the following names were called, several being absent at this time: J. T. Carper, James Coe, R. H. Duncans, Mumford Fountain, E. C. Henderson, G. W. Mallory, John S. Medlock, T. S. Moore, I. T. Sanford, J. W. Stones, Jr., W. M. White. The bishop referred to these men in a spirit of tenderness, their character was passed and they were continued in the same relationship.

Zan W. Holmes was appointed to represent the Book Concern.

Questions Nos. 17, 18, 19, 20, 21, 22, 23, 24, are here answered in the light

the decisions reached by the conference, some in this session and some in later sessions.

Classes, Admissions, and Ordination Elections: In the case of the following the Board of Examiners and the district superintendents vouched for their meeting requirements and the men named were elected as follows:

Advanced to fourth year course of studies, D. C. Carrol.

Continued in the studies of the third year, C. C. Connor, Zebra King. Special case of Z. E. King was left in the hands of his district superintendent.

Continued in studies of the fourth year—

Elected to be ordained elder, elsewhere, under seminary rule, Charles Carrington.

Admitted into full membership and graduated from the course of studies and elected to elders orders, G. W. Kelly, Aron C. Holden, Francis M. Hudspeth; under seminary rule, William A. Robinson; continued on trial in studies first year, J. K. Beal; advanced to studies of the third year, I. C. Greer, Ira B. Loud, Larry W. Miles, Karl Downs, Charles Warren, Robert M. Manifee.

Elected and ordained deacons, Karl Downs, Robert M. Manifee, and James L. Jones. On recommendation of the Board of Examiners and district superintendents it was voted to receive these on trial: E. N. King, James D. Foy, James L. Jones.

On motion of K. W. McMillan and vote of the body the conference voted to hold a regular business session this afternoon at 2:30 o'clock.

FIRST DAY MINUTES OF THE AFTERNOON SESSION

B. A. Byars conducted devotions, Bishop Jones presiding.

Question No. 39 was called: Who are the supernumerary ministers and for how long has each held this relation? J. W. V. Hutchinson, 2 years.

On recommendation of the Conference Relations Committee he was retained in this relationship; his character was passed. J. A. Thomas, 2 years; on recommendation of the Committee on Conference Relations and vote of the conference, J. A. Thomas was located.

Question No. 31 called: Deaths for the year—L. W. Roberts, J. W. Stone, Jr., C. S. Williams.

Question No. 34 called: Who have withdrawn: (a) none; (b) from the ministry and membership of the church—R. H. Moore.

Dr. A. P. Shaw was introduced and addressed the conference in the interest of the Southwestern Christian Advocate. On motion of C. E. Whitiker the conference voted that the pastors report on items as follows: Revivals, Converts and Accessions, Full Members, World Service; Samuel Huston College, and Southwesterns.

After some interventions the reports were received from pastors of the districts as follows: Austin District, Dallas District, San Antonio District, Waco District, and the Victoria District.

SECOND DAY—MORNING SESSION

October 17, 1935

Meeting opened promptly at 9:15 a. m., Bishop Jones in chair.

Communion: Bishop Jones came to this hour much influenced by the program of the day, the communion. After very fitting remarks, Bishop Jones, assisted by the district superintendents and host pastor, administered the communion. Saint Paul M. E. Church choir furnished the music beautifully and ably. More than 200 bowed in reverence at the altar for communion.

Minutes were read and adopted with corrections; also minutes for the afternoon session were read and adopted.

Class for admission was called: Karl Downs, I. C. Greer, Ira B. Loud, L. W. Miles, William A. Robinson, Chas. A. Warren, and formally received.

Introductions: Dr. Starks, C. M. E. Church of Dallas; A. J. Newton, Texas Conference; Revs. L. A. Thigpen, Rev. G. E. D. Belcher, Texas Conference; A. W. Carr, district superintendent Houston District.

Election of Delegates to General Conference: Bishop was asked to appoint tellers. The following appointments were made: J. H. Childs, chairman; J. H. R. Dudley, Wm. Ellison, Jr., Zan W. Holmes, G. A. Deslandes, F. D. Young, and Karl Downs. First ballot was taken. Committee retired to count the ballots.

Dr. S. E. Grannum was introduced and he addressed the conference and presented the members of the faculty of Samuel Huston College as follows: Dean M. L. Harris; Miss V. M. Sounders, superintendent Eliza Dee Home; Dr. Nathaniel Dett, music department; also four young men who sang beautifully several numbers to the delight of all present. C. E. Whitiker led in singing the school song (college) and other numbers. An offering was taken for Samuel Huston College.

By vote of the conference the time for adjournment was extended.

Report on the election was rendered as follows, committee being represented by its chairman, J. H. Childs. Ballot No. 1—total number of ballots 94; defective ballots, none; necessary to elect 48; votes received—S. D. Mosely 3, J. W. Warren 6, C. E. Whitiker 11, S. E. Grannum 21, W. J. King 30, T. B. Echols 55, K. W. McMillan 62. Signed by Board of Tellers: J. H. Childs, J. H. R. Dudley, G. A. Deslandes, William Ellison, Jr., Zan W. Holmes, Fred Young, Karl Downs. Bishop Young declared K. W. McMillan and T. B. Echols elected.

The conference voted to hold a regular business session this afternoon at 3:00 o'clock. Conference proceeded to ballot for two reserve delegates. Ballots taken, sealed and kept by the chairman of the board of tellers until the afternoon session; done by consent of the conference.

Announcements. The benediction was given by the bishop.

SECOND DAY—AFTERNOON SESSION

The men were a bit tardy in coming on the hour. Rev. M. L. Wyatt opened with devotions, Bishop Jones in the chair.

The Board of Tellers was excused to count the ballots. Dr. A. P. Shaw at the request of the bishop presided for about thirty minutes.

Question No. 28 was called. On recommendation of the district superintendents the following were approved as accepted supply pastors. They were

passed in character as follows: Jack Ceaser, W. M. Franklin, R. Grant, B. F. Steward, Richard Weaver, T. W. Stevens.

The tellers having returned at this time the report was called for and made as follows: Report of tellers read by J. H. Childs, president: Ballot No. 1, alternate delegate, total number of ballots 78, defective 1, number to be counted 77, necessary to elect 40; votes received, T. H. Wyatt 1, Zan Holmes 1, F. D. Young 1, G. A. Deslandes 2, J. W. Warren 26, C. E. Whitiker 28, W. J. King 46, S. E. Grannum 46. Signed by board, J. H. Childs, J. H. R. Dudley, G. A. Deslandes, W. M. Ellison, F. D. Young, Zan W. Holmes, Karl Downs. The bishop announced Drs. S. E. Grannum and W. J. King elected.

Call for order of the day. Gulf Side program followed. Mrs. R. E. Jones made the principal address. The conference was told of the staggering loss to the enterprise by the burning of the Jackson House a few months ago, a loss estimated at thousands of dollars. Many had brought special gifts of linens, etc., to give to this cause. An offering of about \$10.00 was taken for this work.

United Session: Bishop Jones in chair. Prof. E. M. Cooper, president of Laymen was invited to the rostrum.

Disciplinary questions Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 were asked. Officers of the Lay Conference were found to be: Prof. E. M. Cooper, president; Prof. J. S. Henry, secretary; Dr. S. L. Brown, treasurer. See Secretary's Record for roll.

There were no persons bonded. Rev. T. H. Wyatt was asked to take charge of the matter, prorate the expense of bonding, etc., to the districts. The annual conference is incorporated according to requirements of the Discipline.

For reports of financial and statistical committees see reports of each.

Askings: A sum was approved for the World Service of \$5870, for the Episcopal Fund \$1250, for General Conference Expense \$755. Dr. S. E. Grannum was present in interest of education at Samuel Huston College; T. B. Echols in interest of Religious Education in New Orleans Area; Dr. W. J. King, president Gammon Seminary; Mrs. R. E. Jones, Gulf Side.

Approved for annual conference benevolences: Samuel Huston College, \$2000.00; Gulf Side, \$750; Religious Education, \$500.00.

Lincoln's birthday is to be observed with a fitting program and offering taken for Samuel Huston College; goal \$2000.00.

A Committee was raised to study plans and report findings one year from now, on plans by which there may be funds that will guarantee a minimum support to each pastor.

The approved claims for the bishop (Episcopal Fund) for the ensuing year were \$1250.00; Conference Claimants, \$2000.00; district superintendents, \$10,000. Laymans President, J. M. Cooper, was presented. He addressed the conference.

Announcements. Benediction was given by T. H. Wyatt.

'THIRD DAY—MORNING SESSION

Meeting opened at 9:30 o'clock. The bishop conducted devotions. The order of the day was Evangelism. We were set in order for this service by the clear and convincing approach to this the major task of our great church, to evangelize the world, by the chairman, Bishop R. E. Jones.

Dr. W. C. Martin, pastor First Church, M. E. Church South, of Dallas,

who from the theme Evangelism spoke with conviction. The conference moved with his compassionate plea.

Dr. W. A. C. Hughes was introduced who spoke from the theme, "Some Unhonored Bible Characters." The conference listened with intense interest to this address. Bishop Jones called Dr. S. E. Grannum and he presided for about thirty minutes. Dr. Charles R. Oatmen of the Board of Pensions and Relief was introduced. He addressed the conference and presented checks: Chartered Funds, \$60.00. From Board of Pensions and Relief \$679.00 was acknowledged.

On motion of Dr. W. J. King the conference voted to send the Board of Pensions and Relief words of appreciation for its great show of interest in our group here in the West Texas Conference especially.

Question 40 being called the following men with the approval of the Conference Relation Committee and vote of the conference, at their request, were given the retired relations: J. W. Downs and E. T. Allen.

On motion of K. W. McMillan the conference voted to hold an afternoon session, a regular business session at 2:30 o'clock.

THIRD DAY—AFTERNOON SESSION

The bishop presided. The meeting opened a bit late. S. N. Harvey conducted devotions.

The journal was read and approved.

Dr. W. A. C. Hughes spoke on the "World Service Enterprise."

Dr. W. J. Holmes spoke on "World Service and the Board of Education."

Announcements. Benediction.

FOURTH DAY—MORNING SESSION

The meeting was opened a little tardily with the bishop in chair. H. O. McCutcheon conducted devotions.

Minutes of previous day's sessions were read and approved.

Bishop Jones called Dr. W. J. King to the chair and he presided about one half hour.

Statisticians Report: Read in part by F. D. Young and ordered rechecked on the point of membership.

Report: Publishing Board report by J. W. Warren stated that last year's minutes were paid for and moved that the minutes be printed. On motion of T. H. Wyatt and approved by the conference Smith Printing Company of Waco is to do the printing; price \$195.00 for 1000 copies.

Auditing committee reported, represented by its chairman, J. H. Childs. See Report.

The bishop read from the El Paso Chamber of Commerce an invitation to hold the next year's session of the conference there. Question No. 49 was called. The following places were put in nomination by their pastors as seat of the next annual conference: El Paso by A. G. Russell, Dallas, St. Paul, by L. L. Haynes. Dallas, St. Paul, received the highest number of votes and was declared the site for the meeting next year. (It was changed to Austin in the afternoon session.)

The bishop asked each man to write the names of three men that they should or would make district superintendents.

Dr. W. J. King read a resolution on a minimum salary plan and asked that there be created a committee to study the plan and report to the next annual conference. Adopted. See Committees.

E. M. Cooper announced the results of the Laymen's election as follows: delegates, E. M. Cooper and Mrs. C. S. Williams; reserves, Prof. J. S. Henry, and Dr. S. L. Brown.

Disciplinary question No. 39 was called. On report and recommendation of the Committee on Conference Relation, and at their request, they voted to give the following men the supernumerary relation: T. M. Bruton, Henry Tollerson, J. L. Wattley. The conference voted to leave the special case of Zebra King to the district superintendent.

The report of the Conference Board of Stewards represented through its secretary, J. J. Hardiman, was read and adopted. See report.

Offering for Gulf Side followed. Remarks by the bishop. Eighty dollars was given.

Youth Conference Program: Much interest had been created for this special program. Dr. W. J. King was requested to preside for the entire program. The program included: music by the St. Paul Junior choir; greeting (welcome) by T. H. Tolbert; Echoes from the Methodist Youth Council of Evanston, Ill., by Charles Warren; address, "Militant Youth," by Karl Downs; address, "City Youth Movement," M. H. Jackson; fraternal greetings from Dr. C. C. Selecman, president Southern Methodist University; greetings, Dr. M. J. Holmes, Board of Education; program of Religious Education in the area by T. B. RECOMMENDATIONS FROM THE COMMITTEE ON YOUNG PEOPLE'S WORK

We wish to express our appreciation to the New Orleans Area Council for adding to its original set-up the young people's section. In times like these we feel the necessity of our Negro young people becoming a part of the United Christian Youth Movement of North America which has chosen for its slogan, "Working With God in Building a Better World." Let us resolve to unite the strength of our Methodist youth in this world-wide program.

We recommend, therefore, that the present program of religious education, which has for its aim the mobilization of the childhood and youth of the area in the interest of the church, receive the wholehearted support of ministers and laymen of our conference;

That we organize in each district Methodist Youth Councils to be responsible for promoting the young people's work within that district;

That we hold during the summer of 1936 a conference-wide young people's institute at a central place. This institute is to be to the West Texas Conference what the Evanston Methodist Youth Council was to the general church; that a commission composed of the Director of Religious Education, presidents of the District Youth Councils, district superintendents, deans of institutes, and five persons at large, selected by the above named group, be approved by this conference as promoter of this project.

Financial Support

1. We recommend that each charge within the conference observe Rally Day in keeping with the provisions of the Discipline (Paragraph 461, Section 7) which reads: "It shall be the duty of the Church School Superintendent, together with the local church school board, to observe Rally Day annually on the first Sunday in October, or on such other day as may be found more convenient, in each school under his care, and to take a collection in each school on that day for the use of the Board of Education in advancement of Church School Work. This collection shall be forwarded to the Board of Education and shall receive credit on World Service apportionment. And that we set as a goal for each Sunday School a per capita of ten cents (10c) per member. This amount will be returned to the New Orleans Area by the Board of Education for the promotion of our religious program.

2. We recommend that each Epworth League and Young People's organization support the "World Comradeship Fund" which provides the means by which Methodist Young People share in the movement, "Christian Youth Building a New World." The local church will receive credit on its World Service quota for whatever amount these young people's organizations send in to the Department of Epworth League and Young People's Work.

3. We further recommend that each district be asked to raise through its district young people's institute or convention the minimum of \$25 for the

support of the Area Program of Religious Education, the said amount to be reported without delay to the office of the resident bishop.

REPORT OF THE AREA DIRECTOR OF RELIGIOUS EDUCATION TO THE WEST TEXAS CONFERENCE

Bishop Jones, Members of the West Texas Conference and Friends:

10-day marks the close of our first ten years of religious education activities within the West Texas Conference. Ten years ago there was not a single young people's institute or Daily Vacation Bible School to be found in our conference, but today we are happy to report that there is not only a district institute and Vacation Bible Schools in every district but there is a Methodist Young People's Council in each district organized and working with the adult leaders to recruit the ranks of our Methodist Church and work with God in building a more Christian world.

Time and space will not permit us to review the work achieved during the past ten years, hence we shall confine our report to the work accomplished during the past conference year.

- I. I have conducted 13 summer and midyear institutes
- II. One Community School of Religious Education in Beaumont, Texas, with 9 churches cooperating—5 Baptist, 2 Methodist, 1 African Methodist, and 1 Congregational.
- III. We have organized 8 Methodist Youth Councils—Six were district councils, the Southwest Conference Youth Council at Philander Smith College, and a City Youth Council in Houston, Texas.
- IV. I have assisted in 6 district group meetings and one school of Methods for Town and Rural Pastors.
- V. I have conducted seven leadership training classes in which program both standard leadership training and the new study courses were used.
- VI. We represented the New Orleans Area in the "National Meeting of Institute Deans and Managers," which met in Evanston, Ill., and at "The International Council of Religious Education" in Chicago. At the invitation of Bishop Mead I was guest speaker at the Methodist Men's Council in Kansas City.
- VII. We have registered in our institutes and youth councils 1282 young people and their leaders, not to mention the visitors and spectators.

Our task as area director of religious education is a gigantic one. Our field covers four great southern states which includes six annual conferences with more than 650 charges. If we were to begin a visitation of charges spending only one week and Sunday to the charge it would take fourteen years to make the round.

With all the promotion we have attempted the institute work has been established in only two of our Negro Annual Conferences. In the other conferences this new educational program is still a distant dream. It is my hope and prayer that within the next two years there will be a full time or part time director of religious education in each of our conferences within the New Orleans Area. The need is without question very great. The laborers are few. We have made a noble beginning but—

So there is a movement in several of our annual conferences to develop larger salaries for these poorly paid men. Various names have been given to this movement. In the Southern California Conference it is called the fellowship fund. The plan is to have every pastor and church contribute to a fund which would be used to supplement the salary of the pastors in the lower register with a view to paying them a minimum salary.
